Neodecortech: Treasury shares buy-back

Neodecortech S.p.A. (“**NDT**” or the “**Company**”), Italian leader in the production of decorative paper for laminated panels and flooring used in the interior design sector, since last November 26 listed on AIM Italia/Mercato Alternativo del Capitale, organised and managed by Borsa Italiana S.p.A. (“AIM Italia”), announces that from January 4, 2018 to January 15, 2018, it has purchased 5,000 Treasury shares (equal to 0,038% of its share capital), with a 3.79 euros average unit price, equivalent to 19,004 euros, following the resolution of the Shareholders Meeting, held on June 23, 2017, authorising the Board of Directors to start the buy-back.
