Disclosure of share buybacks in the period from 29th April to 03rd May 2024

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, as part of the share buyback programme authorized by the Shareholders' Meeting on 19 April 2024, previously disclosed to the market on the same date and on 22 April 2024, in the period from 29th April to 03rd May 2024, it purchased no. 4,000.00 treasury shares at the weighted average price of Euro 2.7875 per share, for a total value of Euro 11,150.00.
